

# Medway Navigation schedule for charges

## Southern Water Authority Act 1982 and 1988

Registration charges 1 April 2010 – 31 March 2011

### POWERED CRAFT

“Powered” means mechanically propelled. Annual charges are to be calculated as follows:

Overall length not exceeding 7.6m	£27.12 per metre	Monthly fee to be calculated as 25% of the above tariff
Overall length exceeding 7.6m	£27.12 per metre up to 7.6 metres plus £24.33 per metre in excess of 7.6 metres up to 11 metres	Weekly fee to be calculated as 12.5% of the above tariff

## Notes

### Hired craft

The charge for a powered craft which is used during the hiring period in each year – April to September – under a contract of hire is twice the charge which would be due in respect of the craft had it not been used in such a contract.

Hire launches issued with a current certificate by the Department of Transport to carry passengers shall pay 1.5 times the annual charge which would be due had it not been used for such purposes.

Tugs shall pay 1.5 times the rate for powered craft.

### Schools, scouts, guides, youth, rowing and canoe clubs (manually propelled craft only)

Where a club undertakes the liability for the registration of its members and remits a block registration fee to the Environment Agency for five or more craft for the year, a reduction of 30% will apply.

### Canoeists – registration exemption

Those canoeists who are current members of the British Canoe Union (BCU) must display or be able to produce their BCU registration if challenged to be exempt from registration fees.

### Charitable events, competitions etc.

In the case of special one-day events a general licence must be applied for at least 28 days in advance. The cost is £76.36.

### Other charges

Use of the Environment Agency's slipway at Hampstead Lock, Yalding is charged at £6.00 per occasion.

### Lifting Bridge at Yalding

Owners of vessels who wish to operate the Lifting Bridge at Yalding may obtain a key from Allington Lock and the Addington office. £10.00 per key. Keys are also available from the Yalding office when staff are in attendance.

### Winter period

Please note, craft may be registered for the three monthly winter period (January–March) upon payment of the one month's charge only.

### Tenders (small boats such as a dinghy, towed or carried by another vessel)

A powered or manually propelled tender shall not be subject to charge if it:

- belongs to a powered craft that has a current registration certificate
- is clearly marked and has been notified to the Environment Agency as a tender to that craft
- is normally attached to that craft and is being used on the navigation for a purpose directly connected with the navigation of the parent craft.
